**WITHDRAWAL FROM SCHOOL**

- ✓ Registration fees are non-refundable, even if a student withdraws or does not attend the school.
- ✓ Incoming students will be charged the full amount for a month even if only attending a portion of that month.
- ✓ Outgoing students will be charged the full amount for a month if exiting after the first full week of that month.

**AUTHORIZATION TO WITHDRAW FUNDS FROM YOUR BANK ACCOUNT**

Marquette Academy will be utilizing a FACTS tuition collection company approved through the Peoria Diocese. NO PAYMENTS WILL COME THROUGH THE SCHOOL. It is mandatory that each family register with FACT's Company. This step must be completed before July 15th. The process takes less than 10 minutes. This is the same company which we currently use for Financial Aid. You will not be registered at Marquette Academy until you go to the totally secure FACTS web site and complete their financial module [www.factsmanagement.com](http://www.factsmanagement.com). This web site will record how you want to pay for your yearly tuition. There are several options: ACH, Credit Card and Invoice payment plans. There are several dates to make payments which we utilize now, 5<sup>th</sup> of the month or the 20<sup>th</sup> of the month or both. Options to pay in full at registration, 2 payments plan (1 @ registration, 1 in January) and a 10 month payment plan beginning August and ending in May. If you choose the invoice payment plan an invoice will be emailed to you and payment is made to
